Reg: Scrutinizer's report in connection with 28th Annual General Meeting of the Company held on Thursday, 7th September 2017 at 10.30 a.m.at The Music Academy, Mini Hall, 168 T.T.K Road. Chennai-600014.

- I. N. Sridharan, Company Secretary in Practice, has been appointed by the Board of Directors of Kothari Petrochemicals Limited ("the Company"), as Scrutinizer for the purpose of scrutinizing the remote e-voting process and voting through polling paper at 28th Annual general Meeting (AGM) of the members of the Company, in a fair and transparent manner and ascertaining the requisite majority on remote e-voting and voting through polling paper carried out, as per the provisions of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014, on the resolutions set out in the Notice dated 10th July, 2017 of the 28th AGM of the members of Kothari Petrochemicals Limited, held on 7th day of September, 2017 at 10.30 a.m. at The Music Academy, Mini Hall. New No-168, TTK Road, Royapettah, Chennai 600014. Accordingly, I submit the report, on completion of remote e-voting process and voting through polling paper, as under:-
 - The Company has engaged the services of CDSL as the Authorised Agency to provide secured system for remote e-voting process.
 - The remote e-voting period remained open from 09.00 a.m. on 3rd September, 2017 up to 05.00 p.m. on 6th September, 2017.
 - The cut-off date for the purpose of determining the entitlement for voting, by remote evoting or voting through polling paper, on the proposed resolutions was 31st August, 2017.



- 4. After the close of period for remote e-voting, the details of members, such as their names, folio numbers, numbers of shares held, who had cast votes through remote e-voting, were downloaded from the e-voting website of CDSL, for the purpose of ensuring that members who have cast their votes through remote e-voting do not vote again at the 28th AGM.
- At the 28th AGM, after the declaration of Poll by the Chairperson, one ballot box kept for polling was locked in my presence with due identification marks placed by me.
- The locked ballot box was subsequently opened in my presence along with two witnesses 1.
 Mr. S. Krishnan and 2.Ms. Madhu. B who is not in the employment of the Company and poll papers was diligently scrutinized.
- The polling papers, which were incomplete and/or which were otherwise found defective have been treated as invalid and kept separately.
- 8. After counting the votes cast by the members present at the 28th AGM, through polling paper, the votes cast through remote e-voting were unblocked on 7th September, 2017, around 12.00° noon in the presence of two witnesses, 1. Mr. Mr. S. Krishnan and 2. Ms. Madhu. B who are not in the employment of the Company.
- Thereafter, the details containing, inter alia, the information about equity shareholders voting 'For' and 'Against' the resolutions, were generated from the e-voting website of CDSL.
