- (a) The Ministry of Corporate Affairs vide its Circular No. 03/2025 dated September 22, 2025 read with Circular No. 09/2024 dated September 19, 2024 read with Circular No. 09/2023 dated September 25, 2023 read with Circular No. 10/2022 dated December 28, 2022 read with Circular No. 02/2022 dated May 05, 2022 read with Circular No. 21/2021 dated December 14, 2021 read with Circular No. 02/2021 dated January 13, 2021 read with Circular No. 20/2020 dated May 05, 2020 read with Circular No.17/2020 dated April 13, 2020 read with Circular No.14/2020 dated April 8, 2020 allows conducting of Annual General Meeting of the Company through Video Conferencing (VC) or Other Audio Visual Means (OAVM) without the physical presence of the members for the meeting at a common venue till further order. In terms of the said Circulars and in compliance with the provisions of the Companies Act, 2013 and SEBI (LODR) Regulations, 2015, the AGM of the Company is being held through VC / OAVM. Hence, Members can attend and participate in the AGM through VC/OAVM only. The deemed venue for the AGM shall be the Registered Office of the Company. The detailed procedure for participating in the meeting through VC/ OAVM is appended herewith and also available at the Company's website:www.kotharipetrochemicals.com/investors/annual-reports/

- b) Since the AGM is being conducted through VC/OAVM, the facility for appointment of proxies by the Members will not be available for this AGM and hence, the Proxy Form, Attendance Slip and Route Map are not annexed to this Notice.
- c) Body Corporate members are requested to send to the Company a certified copy of the Board Resolution / Power of Attorney authorizing their representative to attend and vote in the AGM through VC / OAVM on its behalf and to vote through remote e-voting. Members of the Company under the category of Institutional Investors are encouraged to attend and vote at the AGM.
- d) The Explanatory Statement pursuant to Section 102 of the Companies Act, 2013, which sets out details relating to Special Business at the meeting, is annexed hereto.
- e) The Register of Members and Share Transfer Books of the Company will remain closed from Saturday, 08th August 2026 to Friday, 14th August 2026 (both days inclusive) on account of the Annual General Meeting.

In this connection, the Company has issued reminder letters to all shareholders holding shares in physical, who have not updated any of the above said details. Any dividend payment with respect to physical folios will be only through electronic mode only upon complying with the requirements of updation of all the details by the Investor as said above.

- (i) Pursuant to Regulation 40 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and SEBI Circular dated 25th January 2022, any request for transfer, transmission or transposition of shares will be processed in accordance with SEBI requirements and securities shall be issued only in dematerialized form.

- (l) In compliance with the aforesaid MCA Circulars and pursuant to amended Regulation 36 of SEBI (LODR) Regulations, 2015, the Notice of the AGM along with the Annual Report 2025-26 is being sent through electronic mode to those Members whose email addresses are registered with the Company / Depositories. Further, in compliance with Reg 36(1)(b) of SEBI (LODR), Regulations, 2015, a letter providing web link, including exact path of Annual Report is available, is being sent to those members whose e-mail ids are not registered with the Company / RTA / Depository Participants.
- (m) The Register of Directors' and Key Managerial Personnel and their shareholding maintained under Section 170 of the Companies Act, 2013, the Register of Contracts or arrangements in which the Directors are interested under Section 189 of the Companies Act, 2013 and all other documents referred to in the Notice will be available for inspection in electronic mode. Members can send an e-mail to secdept@hckgroup.com requesting for inspection of the Registers.
- (n) The attendance of the Members attending the AGM through VC/OAVM will be counted for the purpose of ascertaining the quorum under Section 103 of the Companies Act, 2013.

Voting through Electronic means:

Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 (as amended) and MCA Circulars, the Company shall provide the facility of remote e-voting to its Members in respect of the business to be transacted at the AGM.

For this purpose, the Company has entered into an agreement with Central Depository Services (India) Limited (CDSL) for facilitating voting through electronic means, as

the authorized e-Voting agency. The facility of casting votes by a member using remote e-voting as well as the e-voting system on the date of the AGM through VC or OAVM will be provided by CDSL.

The instructions to Shareholders for remote E-voting and E-voting during AGM and joining meeting through VC/OAVM are as under:

- (i) The remote e-voting period begins on Monday, 10th August 2026 at 9.00 A.M. and ends on Thursday, 13th August 2026 at 5.00 P.M. During this period, Members holding shares either in physical form or in dematerialized form, as on the cut-off date i.e. Friday, 07th August 2026 may cast their vote electronically. The remote e-voting module shall be disabled by CDSL for voting thereafter.
- (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
- (iii) Pursuant to SEBI Circular No. **SEBI/HO/CFD/CMD/ CIR/P/2020/242 dated 09.12.2020**, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' Resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level. There are also multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India which necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to all the demat account holders, by way of a single login credential, through their demat accounts / websites of Depositories / Depository participants. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

- (iv) In terms of SEBI Circular No. **SEBI/HO/CFD/CMD/ CIR/P/2020/242 dated 09.12.2020**, on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

- 2) Click on "Shareholders / Members" module.
- 3) Now enter your User ID
 - a. For CDSL : 16 digits beneficiary ID,
 - b. For NSDL : 8 Character DP ID followed by 8 Digits Client ID,
 - c. Shareholders holding shares in Physical Form should enter Folio Number registered with the Company.

Kindly note that this password is to be also used by the demat holders for voting for Resolutions of any other company on which they are eligible to vote, provided that company opts for e-voting through CDSL platform. - 10) Click on the EVSN of relevant Company name i.e. **Kothari Petrochemicals Limited** on which you choose to vote.
- 11) On the voting page, you will see "RESOLUTION DESCRIPTION" and against the same the option "YES/NO" for voting. Select the option YES or NO as desired. The option YES implies that you assent

to the Resolution and option NO implies that you dissent to the Resolution.

- 12) Click on the "RESOLUTIONS FILE LINK" if you wish to view the entire Resolution details.
- 13) After selecting the Resolution, you have decided to vote on, click on "SUBMIT". A confirmation box will be displayed. If you wish to confirm your vote, click on "OK", else to change your vote, click on "CANCEL" and accordingly modify your vote.
- 14) Once you "CONFIRM" your vote on the Resolution, you will not be allowed to modify your vote.
- 15) You can also take a print of the votes cast by clicking on "Click here to print" option on the Voting page.
- 16) If a demat account holder has forgotten the login password then Enter the User ID and the image verification code and click on Forgot Password & enter the details as prompted by the system.
- 17) There is also an optional provision to upload BR/ POA if any uploaded, which will be made available to scrutinizer for verification.

(vi) Additional Facility for Non - Individual Shareholders and Custodians - For Remote Voting only.

- (a) Non-Individual shareholders (i.e. other than Individuals, HUF, NRI etc.) and Custodians are required to log on to www.evotingindia.com and register themselves in the "Corporates" module.
- (b) A scanned copy of the Registration Form bearing the stamp and sign of the entity should be emailed to helpdesk.evoting@cdslindia.com.
- (c) After receiving the login details a Compliance User should be created using the admin login and password. The Compliance User would be able to link the account(s) for which they wish to vote on.
- (d) The list of accounts linked in the login will be mapped automatically and can be delink in case of any wrong mapping.

To the Members

The Directors are pleased to present the 37th Annual Report of the Company together with the Audited Financial Statements for the year ended 31st March 2026.

Financial Highlights

Revenue from operations for the year stood at ₹ 59,138.67 lakhs, as against ₹ 57,733.94 lakhs in the previous year. This variation is mainly attributable to sales volume of Poly Iso Butylene (PIB), which is increased from 37,440 metric tons to 39,930 metric tons.

The Company achieved a Profit Before Tax of ₹ 9,676.98 lakhs for the financial year ended 31st March 2026, compared to ₹ 8,220.78 lakhs in the previous year. The improvement is mainly on account of higher sales volumes supported by a more favourable raw material mix.

Status of the Plant

Your Company experienced a reduction in production during FY 2025-2026 compared to Annual plan was primarily due to raw material supply constraints. This was largely driven by a 45 - day emergency shutdown at the nearby Refinery during October 2025, as well as disruptions at one of the raw material suppliers during the heavy monsoon period.

Despite these challenges, the plant operated for 358 days during the year without any major internal shutdowns. However, limited raw material availability resulted in operations at reduced throughput, thereby impacting overall production.

The supply of raw water from the Metro Water Board's TTRO facility was still inconsistent, with frequent quality issues and interruptions. As a result, the Company had to procure the water externally at higher costs.

A collective representation was made by industries in the Manali region, and corrective actions are currently underway by the authorities. On a positive note, the plant's rainwater harvesting infrastructure proved highly effective. Significant quantities of rainwater were collected and utilized, resulting in substantial cost savings and reduced dependency on external water sources.

The Captive Power Plant continued to perform reliably, operating for 308 days during the year. Additional power requirements were met through the State Electricity Board grid. Further strengthening our renewable energy footprint, an additional 60 kW solar capacity was installed, augmenting the existing 247 kW system. Necessary approvals from TANGEDCO were obtained, and the entire solar generation was utilized for internal consumption, with no export to the grid.

The Company continues to uphold its globally recognized following certifications:

- (i) ISO 9001:2015 (Quality Management)
- (ii) ISO 14001:2015 (Environmental Management)
- (iii) ISO 45001:2018 (Occupational Health & Safety)
- (iv) ISO 50001 (Energy Management)

These certifications reflect our sustained commitment proving to operational excellence, environmental stewardship, energy efficiency, and employee well-being.

All statutory requirements under Petroleum and Explosives Safety Organisation (PESO) and Directorate of Industrial Safety and Health (DISH) have been fully complied with.

Preventive and predictive maintenance systems are rigorously implemented to ensure that the plant remains in safe and reliable operating condition.

Performance

Your Company has achieved an exceptional milestone of 13,126 accident-free days since inception, reflecting a deeply ingrained safety culture supported by continuous training for safe and efficient plant operations and project execution. During FY 2025 - 26, the Company produced 39,163 MT of Polyisobutylene (PIB), achieving 90.35% of the annual plan despite feedstock and operational challenges.

The Company was also honoured with several prestigious recognitions during the year, including the Second Prize from DISH, Government of Tamil Nadu, the Best Energy Efficient Unit Award from Confederation of Indian Industry (CII) (2025), and the Star Award for Occupational Health, Safety & Environment from National Safety Council (NSC) (August 2025).

Based on learnings from the previous year's monsoon flooding in the Manali industrial region, proactive flood mitigation measures in the company were undertaken, including deepening and widening rainwater drainage gutters and revamping an existing natural pond with geomembrane lining to store around 4,000 KL of rainwater.

A strategic operational improvement study was undertaken focusing on reactor debottlenecking, cooling tower upgrades, enhanced equipment reliability, and improved thermal efficiency. Energy optimization measures, including a dedicated cooling tower line, enabled energy consumption to be maintained at 0.329 TOE/MT of PIB in FY 2025-26, compared with 0.327 TOE/MT in FY 2024-25, broadly in line with the previous year despite higher consumption of steam for utilizing enhanced supply of lean feedstock by the Government Refinery.

With respect to the freehold land acquired in Andhra Pradesh, the Company is currently evaluating various product opportunities and is working with engineering consultants to finalise the project plans.

Plant Automation

The Safe Track Digital Portal has improved Environment, Health, and Safety (EHS) governance by providing real time visibility, accountability, and traceability of safety processes. Its enhancement with additional permit categories and Lockout Tagout (LOTO) modules has further strengthened a proactive safety culture.

All Quality Check activities have been fully digitized through the Laboratory Information Management System (LIMS) platform, enabling seamless sample tracking, standardized test reporting, and audit ready data management. Certificate of Analysis (COA) generation and sampling processes have

also been digitized to improve accuracy, consistency, and traceability.

A 24x7 digital gate management system has been implemented to streamline vehicle movement monitoring, improving logistics coordination and site security. Smart energy meters have been installed across critical utility nodes and integrated with a centralized Energy Monitoring System, enabling real-time monitoring and optimization of steam, power, and fuel consumption.

Safety

The Company continues to strengthen its safety culture through regular safety audits, Behaviour-Based Safety (BBS) programs, and Field-Level Risk Assessments (FLRA). An external safety audit validated ongoing improvements, while a detailed Process Safety Management (PSM) gap assessment based on the Centre for Chemical Process Safety (CCPS) framework has guided corrective actions.

The Company is currently implementing key PSM modules, including Standard Operating Procedures (SOPs), Alarm Management, BBS, and Asset Integrity, to enhance operational discipline and support incident-free operations.

Pollution and Environment compliances

The Company maintained strong environmental performance through effective monitoring of effluents, emissions, and waste management. Online systems remain calibrated and integrated with TNPCB's CARE Air and Water portals for real-time compliance. The Company achieved full compliance during FY 2025-26, with no regulatory complaints, and holds valid Consent to Operate (CTO) and Fire License approvals for PIB manufacturing until March 2028.

Research and Development

During the year, the Company strengthened its R&D capabilities through an investment of ₹136.87 lakhs in advanced analytical instruments and infrastructure, along with onboarding specialized personnel to enhance technical expertise and research efficiency.

The Company also renewed its Department of Scientific & Industrial Research (DSIR) recognition for a further three years, valid until 31st March 2028, reaffirming its commitment to innovation and scientific excellence.

R&D and Product Development teams continued to focus on new applications and value-added products aligned with market needs. To support scale up from lab to commercial stage, dedicated demonstration-scale facilities are being established.

Further strengthening its innovation infrastructure, the Company commissioned its third Synthesis Laboratory building during the year, equipped with an integrated hydrogenation trial facility.

B read with Regulation 9 of the SEBI (Prohibition of Insider Trading) Regulations, 2015. Upon taking cognizance of the same and considering that this is the first instance of non-compliance, due to the inadvertent sale, with no intent to violate regulations or gain any undue benefit, and that the Director has incurred a loss, a Warning Letter was issued by the Company to the Director, insisting not to execute any contra trade for six months, obtain pre-clearance whenever required and not to trade during the notional trading window period. Further, the Company has reported the aforesaid violation to National Stock Exchange of India Limited on April 18, 2026 as required under SEBI Circular No. SEBI/HO/ISD/ISD/ CIR/P/2020/135 dated July 23, 2020.

8. I further report that during the audit period, the Company did not have any events which had a major bearing on the Company's affairs in pursuance of the laws, rules, regulations, guidelines, standards, etc referred to above.

Management Discussion and Analysis

Industry Structure & Development :

The Indian Polyisobutylene industry witnessed steady demand during FY 2025-26, supported by growth in the automotive, industrial lubricants, and infrastructure sectors. However, the year was marked by supply-side constraints and volatility in feedstock availability and pricing, driven by global geopolitical developments and domestic policy priorities.

Polyisobutylene (PIB) continues to be a critical input for lubricant additives, fuel additives, and specialty chemical applications. The domestic availability of PIB plays a vital role in supporting India's lubricant and automotive ecosystem and reducing dependence on imports.

The demand for value-added PIB derivatives in lube dispersants is steadily increasing, particularly with the expansion of global lubricant additive manufacturers in India.

Outlook :

The Company is engaged in the manufacture of Polyisobutylene (PIB) and continues to be a key domestic supplier catering to lubricant additive manufacturers, oil marketing companies, and other customer segments.

The Company operates its manufacturing facilities at Manali, Chennai, with an installed capacity of 48,000 MT per annum. The strategic focus remains on ensuring consistent supply of PIB to customers, strengthening feedstock sourcing strategies, expanding into value-added PIB derivatives, and enhancing operational efficiencies. The long-term outlook for the business remains positive, supported by strong domestic demand fundamentals and the continued focus on import substitution.

Opportunities :

The Company remains well positioned to benefit from increasing demand for lubricant additives in India and the continued focus on import substitution. The Company is actively evaluating strategic initiatives including expansion into value - added PIB derivatives, capacity augmentation at existing and new locations, and strengthening feedstock security through diversified sourcing strategies.

Risks, Concerns & Threats :

During the year, reduced availability of feedstock from Government Refinery sources, due to prioritization of LPG supply to domestic towards the end of the year, led to increased dependence on alternate sourcing mechanisms to sustain operations.

Volatility in global energy prices continues to affect feedstock economics. The Company also monitors key risks relating to dependence on refinery-linked C4 streams, exposure to global crude and naphtha fluctuations, government policies affecting LPG and petrochemical feedstocks, and competition from imports.

The Company has adopted appropriate mitigation strategies, including diversification of feedstock sources, operational flexibility, and continued engagement with stakeholders to ensure supply continuity.

Internal Control Systems and their adequacy :

The Company has established a robust internal control system framework encompassing all aspects of business operations, aimed at safeguarding assets, ensuring operational accuracy, and maintaining compliance with applicable regulations. Regular internal audits are systematically conducted across critical functional areas, and audit findings are reviewed by the Audit Committee, Board of Directors, and senior management, ensuring proactive risk mitigation and timely corrective actions.

Clear, documented policies govern expenditure, authorization, monitoring, and control processes. All capital investment decisions undergo detailed feasibility evaluations, and multi-level reviews, ensuring alignment with strategic objectives and risk tolerance. Both capital and revenue expenditures are tracked against approved budgets through comprehensive reporting systems, fostering financial discipline, transparency, and accountability.

Additionally, continuous investment in training and awareness programs ensure that employees remain compliant with internal control policies and risk protocols, thereby fostering a strong culture of integrity and governance.

Human Resources / Industrial Relations :

At KPL, our employees are our most valuable resource. Their continuous development, engagement, and performance are central to our long-term success and organizational stability.

Throughout the year, our employees participated in various in-house training programs under the Employee Development Program, designed to build both technical and soft skills. We introduced a structured Performance Management System to foster individual accountability, align objectives across teams, and promote a culture of continuous improvement through clear goal-setting, performance evaluations, and feedback.

Industrial relations remained harmonious throughout the year. Our proactive and collaborative approach, aligned with industry best practices in the manufacturing sector has fostered constructive dialogue and early resolution of issues, contributing to a positive and productive workplace environment.

The Company also invested in enhancing employee welfare and infrastructure by establishing a state-of-the-art integrated facility comprising an Occupational Health Centre, employee cloakrooms, and a modern training centre.

As of **31st March 2026**, our petrochemical operations employed a total of **200 employees**.

NOTES FORMING PART OF FINANCIAL STATEMENTS

Note 1

CORPORATE OVERVIEW

Kothari Petrochemicals Limited (referred to as "KPL" or the "Company") is the Manufacturer of Poly Iso Butylene. The registered office of the Company is situated at "Kothari Buildings", No.: 115, Mahatma Gandhi Salai, Nungambakkam, Chennai - 600 034.

AUTHORIZATION OF FINANCIAL STATEMENTS

The Financial Statements for the year ended 31st March 2026 have been approved for issue by the Board of Directors of the Company on 5th May 2026 and are subject to adoption by the shareholders in the ensuing Annual General Meeting.

MATERIAL ACCOUNTING POLICIES

i. Statement of Compliance :

The financial statements have been prepared in accordance with the Indian Accounting Standards ("Ind AS") notified under the Companies (Indian Accounting Standards) Rules, 2015, as amended, and other relevant provisions of the Companies Act, 2013.

ii. Basis of preparation and presentation :

The financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period, as explained in the accounting policies below.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Company takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these financial statements is determined on such a basis, leasing transactions that are within the scope of Ind AS 116, and measurements that have some similarities to fair value but are not fair value, such as net realizable value in Ind AS 2 or value in use in Ind AS 36.

In addition, for financial reporting purposes, fair value measurements are Categorised into Level 1, 2, or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The material accounting policies are set out below :

iii. Revenue Recognition :

Revenue is recognized upon transfer of control of promised products or services to customers in an amount that reflects the consideration we expect to receive in exchange for those products or services. Revenue is presented net of discounts, commissions other price concessions and Goods and services tax (GST).

The Company considers indicators for assessing the transfer of control, including :

- a. the entity has a present right to payment for the asset.
- b. the customer has legal title to the asset.
- c. the entity has transferred physical possession of the asset.
- d. the customer has the significant risks and re-wards of ownership of the asset.
- e. the customer has accepted the asset.

iv. Dividend, interest and other income

- Dividend income from investments is recognized when the right to receive payment has been established.
- Interest income is recognized on a time proportion basis taking into account the amount outstanding and the interest rate applicable in line with the effective interest rate method.
- Operating Lease rental income is accounted on straight line basis over the term of the relevant lease.
- Insurance claims are accounted on the basis of claims admitted and to the extent that there is no uncertainty in receiving the claims.
- Export benefits are accounted for at realizable value in the year of exports based on eligibility and when there is no uncertainty in receiving the same.

NOTES FORMING PART OF FINANCIAL STATEMENTS**v. Leases :**

The Company, as a lessee, recognises a right-of-use asset and a corresponding lease liability at the commencement date of the lease for all lease arrangements, except short-term leases and leases of low-value assets.

In the case of operating leases, Ind AS 116 requires lessees to determine the lease term as the non-cancellable period of a lease adjusted with any option to extend or terminate the lease, if the use of such option is reasonably certain. The Company makes an assessment on the expected lease term on a lease-by-lease basis and thereby assesses whether it is reasonably certain that any options to extend or terminate the contract will be exercised.

Lease rentals having lease term within 12 months are charged or recognized in the Statement of Profit and Loss on a straight-line basis over the lease term.

The right to use assets are initially recognized at cost which comprises an amount equal to discounted lease liability plus any initial direct costs. They are subsequently measured at cost less accumulated depreciation and impairment losses.

Lease liability is initially measured at amortized cost at the present value of the future lease payment. The lease payments are discounted using the interest rate implicit in the lease or, if not readily determinable using the incremental borrowing rate for the company.

vi. Borrowing costs :

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets are added to the cost of those assets, until such time the assets are ready for their intended use or sale.

Interest income earned on the temporary investments of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalization.

All other borrowing costs are recognized in the Statement of Profit and Loss in the period in which they are incurred. Borrowing costs are not included in the value of inventories.

vii. Employee Benefits :**(a) Post Employment Employee Benefits**

Payments to defined contribution retirement benefit plans are recognized as an expense when employees have rendered service entitling them to the contributions.

For defined benefit retirement benefit plans, the cost of providing benefits is determined using the projected unit credit method, with actuarial valuations being carried out at the end of each reporting period.

Defined benefit costs are categorized as follows :

- Service cost (including current service cost, past service cost, as well as gains and losses on curtailments and settlements);
- Net interest expense or income; and
- Re-measurement.

The Company presents the first two components of defined benefit costs in Statement of Profit and Loss in the line item 'Employee benefits expense'.

Past service cost is recognized in Statement of Profit and Loss in the period of a plan amendment.

Net interest is calculated by applying the discount rate at the beginning of the period to the net defined benefit liability or asset.

Re-measurement, comprising actuarial gains and losses, the effect of the changes to the asset ceiling (if applicable) and the return on plan assets (excluding net interest), is reflected immediately in the balance sheet with a charge or credit recognized in other comprehensive income in the period in which they occur. Re-measurement recognized in Other Comprehensive Income is reflected immediately in Retained Earnings and is not reclassified to Statement of Profit and Loss.

- Contribution to Provident Fund is in the nature of defined contribution plan and are made to Employees Provident Fund Scheme, 1952. Under the scheme the company is required to contribute a specified percentage of payroll cost to the Scheme. The interest as declared by the Government from time to time accrues to the employees under the scheme.
- Contribution to Superannuation Fund is in the nature of defined contribution plan and is remitted to IndusInd Nippon Life Insurance Company Limited. Under the scheme the company is required to contribute a specified percentage of payroll cost to underwriters to enable them to make settlement to the qualifying employees.
- Contribution to Employees' Group Gratuity-cum Life Assurance scheme is in the nature of Defined benefit plan and is remitted to IndusInd Nippon Life Insurance Company Limited. The Scheme provides for lump sum payment to vested employees at retirement, death while in employment or on termination of employment.
- Liability for unavailed leave for employees is considered as short term benefit and provided accordingly in books. Liability of unavailed sick leave for employees is considered as long term benefit.

(b) Short-term employee benefits

Liabilities recognized in respect of short-term employee benefits are measured at the undiscounted amount of the benefits expected to be paid in exchange for the related service and recognized as an expense in the year they are incurred.

(c) Other Long term employee benefits

Long term employee benefit liabilities other than post-retirement benefit are measured on the basis of actuarial valuation on respective reporting dates using projected unit credit method and recognized in the profit and loss for the period.

viii. Earnings per Share :

The Company presents basic and diluted earnings per share (EPS) data for its equity shares.

Basic EPS is calculated by dividing the Profit or Loss attributable to equity shareholders by the weighted average number of equity shares outstanding during the period.

Diluted EPS is determined by adjusting the Profit or Loss attributable to equity shareholders and the weighted average number of equity shares outstanding for the effects of all dilutive potential equity shares.

ix. Taxation :

Income tax expense represents the sum of the tax currently payable and deferred tax.

The Company has opted for taxation under Section 115BAA of the Income-tax Act, 1961 (Section 200 of Income-tax Act, 2025.)

a. Current tax

Current tax is the amount of tax payable on the taxable income for the year as determined in accordance with the applicable tax rates and the provisions of the Income tax Act, 1961 and other applicable tax laws.

b. Deferred tax

Deferred tax is recognized on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are recognized for all taxable temporary differences. Deferred tax assets are recognized for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilized.

Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the

period in which the liability is settled or the asset realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

c. Current and deferred tax for the year

Current and deferred tax are recognized in Statement of Profit and Loss, except when they relate to items that are recognized in Other Comprehensive Income or directly in equity, in which case, the current and deferred tax are also recognized in other comprehensive income or directly in equity respectively.

x. Property, Plant and Equipment :

All Property, Plant and Equipment are measured at cost, less accumulated depreciation and impairment losses, if any.

The cost of asset includes the purchase cost including import duties and non-refundable taxes, and any costs that are directly attributable of bringing an asset to the location and condition of its intended use.

The carrying amount of the replaced parts are derecognized. All other repairs and maintenance costs are recognized in Statement of Profit and Loss as incurred.

Subsequent expenditure related to an item of Property, Plant and Equipment is added to its carrying value only when economic benefits are expected to accrue for a period beyond one year.

Depreciation is provided on a straight-line basis over the estimated useful lives of the assets. The useful lives are based on Schedule II to the Companies Act, 2013, except where management has assessed different useful lives based on technical evaluation.

Assets costing ₹ 5,000 and below are depreciated in the year of acquisition.

Assets on leased premises are depreciated on the remaining period of lease or as per the useful life prescribed in Schedule II of the Companies Act, 2013, whichever is earlier.

Depreciable amount for assets is the cost of an asset, or other amount substituted for cost, less its estimated residual value not more than 5% of Cost.

For certain items of plant and machinery, the useful life adopted is based on internal technical evaluation and best represents the period over which the Company expects to use these assets.

The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of Property, Plant and Equipment is derecognized upon disposal or when no future economic benefits are expected to arise from the continued use of the asset.

Gains / Losses arising on the disposal or retirement of an item of Property, Plant and Equipment are determined as the difference between the sales proceeds or net realizable value and the carrying amount of the asset and is recognized in Statement of Profit and Loss.

The carrying values of assets / cash generating units at each balance sheet date are reviewed for impairment. If any indication of impairment exists, the recoverable amount of such assets is estimated and impairment is recognized, if the carrying amount of these assets exceeds their recoverable amount. The recoverable amount is the greater of the net selling price and their value-in-use. Value-in-use is arrived at by discounting the future cash flows to their present value based on an appropriate discount factor.

When there is indication that an impairment loss recognized for an asset in earlier accounting periods no longer exists or may have decreased, such reversal of impairment loss is recognized in the Statement of Profit and Loss.

xi. Inventories :

Inventories are stated at the lower of cost and net realizable value. Net realizable value represents the estimated selling price for inventories, less all estimated costs of completion and costs necessary to make the sale.

Cost of inventory comprises of purchase price, cost of conversion and other directly attributable costs that have been incurred in bringing the inventories to their

respective present location and condition. The cost of inventories is computed on weighted average basis.

Inventories are written down on a case-by-case basis if the anticipated net realizable value declines below the carrying amount of the inventories in the Statement of Profit and Loss.

xii. Provisions, contingent liabilities and contingent assets :

A provision is recognized when the Company has a present obligation as a result of past events and it is probable that an outflow of resources will be required to settle the obligation in respect of which a reliable estimate can be made.

Provisions (excluding retirement benefits) are not discounted to their present value except in the cases where time value of money is material and are determined based on the best estimate required to settle the obligation at the balance sheet date and are reviewed at each balance sheet date and adjusted to reflect the current best estimates.

Contingent liabilities in relation to claims against the Company, includes legal, contractual and claims arising from custom. The assessment of the existence, and potential quantum, of contingencies inherently involves the exercise of significant judgment and the use of estimates regarding the outcome of future events. Contingent liabilities are disclosed in the notes. Contingent assets are not recognized in the financial statements.

xiii. Investment Property :

Investment properties are properties held to earn rentals and/or for capital appreciation (including property under construction for such purposes). Investment properties are measured initially at cost including transactions costs. Subsequent to initial recognition, investment properties are measured at cost less accumulated depreciation over useful life of 60 years on straight line basis and impairment losses, if any. Though, the Company measures investment property using cost-based measurement, the fair value of investment property is disclosed in Notes. Fair values are determined based on an annual evaluation performed by a Chartered Engineer. Rental income is disclosed under Note 20 in Statement of Profit and Loss.

xiv. Intangible Assets :

Intangible assets with finite useful lives that are acquired separately are carried at cost, less accumulated amortization and accumulated impairment losses. Amortization is recognized on a straight-line basis over

their estimated useful lives. The estimated useful life and amortization method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis.

Expenditure on research activities is recognised as an expense in the Statement of Profit and Loss as incurred.

Software and licenses are amortized over useful life of not exceeding 5 years.

xv. Financial instruments :

Financial assets and financial liabilities are recognized when the Company becomes a party to the contractual provisions of the instruments.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognized immediately in Statement of Profit and Loss.

xvi. Financial assets :

All regular way purchases or sales of financial assets are recognized and derecognized on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the market place.

All recognized financial assets are subsequently measured in their entirety at amortized cost or fair value, depending on the classification of the financial assets.

a. Classification of financial assets

Debt instruments (including Trade receivables, Loans and Other Financial Assets) that meet the following conditions are subsequently measured at amortised cost (except for debt instruments that are designated as at fair value through profit or loss on initial recognition):

- the asset is held within a business model whose objective is to hold assets in order to collect contractual cash flows; and
- the contractual terms of the instrument give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

All other financial assets are subsequently measured at fair value.

b. Effective interest method

The effective interest method is a method of calculating the amortised cost of a debt instrument and of allocating interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the debt instrument, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

Income or Expense is recognized on an effective interest basis for debt instruments other than those financial liabilities classified as at FVTPL. Interest income or expense is recognized in Statement of Profit and Loss.

c. Impairment of financial assets

The Company assesses on a forward looking basis the expected credit losses associated with its assets carried at amortized cost. The impairment methodology applied depends on whether there has been significant increase in credit risk.

For trade receivables, the Company applies the simplified approach permitted by Ind AS 109 Financial Instruments, which requires expected credit losses to be recognized from initial recognition of the receivables.

d. Derecognition of financial assets

The Company derecognises a financial asset when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another party.

e. Derivative financial instruments

The Company uses forward contracts to hedge its foreign currency risks. Such derivative financial instruments are initially recognized at fair value on the date on which a derivative contract is entered into and are subsequently re-measured at fair value. Derivatives are carried as financial assets when the fair value is positive and as financial liabilities when the fair value is negative. Any gains or losses arising from changes in the fair value of derivatives are taken directly to Statement of Profit and Loss.

NOTES FORMING PART OF FINANCIAL STATEMENTS**xvii. Financial liabilities :**

Borrowings, trade payables and other financial liabilities are initially recognized at the value of the respective contractual obligations.

They are subsequently measured at amortised cost using effective interest method. Any discount or premium on settlement is recognized in the Statement of Profit and Loss as finance cost over the life of the liability using the effective interest method and adjusted to the liability figure disclosed in the Balance Sheet.

Derecognition of financial liabilities

The Company derecognises financial liabilities when, and only when, the Company's obligations are discharged, cancelled or have expired.

xviii. Cash flow statement

Cash flows are reported using the indirect method, whereby profit / (loss) before exceptional items and tax is adjusted for the effects of transactions of non-cash nature and any deferrals or accruals of past or future cash receipts or payments. The company considers all liquid investments, which are readily convertible into known amounts of cash, that are subject to an insignificant risk of change in value to be cash equivalents. Cash and cash equivalents consist of balances with banks which are unrestricted for withdrawal or usage except fixed deposit with original maturity more than 3 months.

xix. Functional and presentation currency and Foreign Currency Transactions

Items included in the financial statements of the Company are measured using the currency of the primary economic environment in which these entity operate (i.e. the "functional currency"). The financial statements are presented in Indian Rupee, the national currency of India, which is the functional currency of the Company.

In preparing the financial statements of the Company, transactions in currencies other than the entity's functional currency (foreign currencies) are recognized at the rates of exchange prevailing at the dates of the transactions. At the end of each reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date.

Exchange differences on monetary items are recognized in Statement of Profit and Loss in the period in which they arise.

xx. Key estimates and assumptions

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Key assumption concerning the future, and other key sources of estimation uncertainty at the end of the reporting period that may have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year is as given below.

- (i) Useful life of property, plant, equipment, Investment property & Intangibles Assets.
- (ii) Provision for income taxes and deferred taxes.
- (iii) Provisions for Defined benefit plan.

Fair value measurement and valuation processes:

Some of the Company's assets and liabilities are measured at fair value for financial reporting purposes. In estimating the fair value of an asset or a liability, the Company uses market-observable data to the extent it is available. Where Level 1 inputs are not available, the Company engages third-party qualified valuers to perform the valuation.

xxi. Operating Cycle

Based on the nature of products / activities of the Company and the normal time between acquisition of assets and their realization in cash or cash equivalents, the Company has determined its operating cycle as 12 months for the purpose of classification of its assets and liabilities as current and non-current.

xxii. Recent accounting pronouncements

Ministry of Corporate Affairs ("MCA") notifies new standards or amendments to the existing standards under Companies (Indian Accounting Standards) Rules as issued from time to time. For the year ended March 31, 2026, MCA has notified changes in few disclosures in Ind AS 1 - Presentation of Financial Statements, Ind AS 7- Statement of Cash Flows, Ind AS 12 - pertaining to International tax reform (pillar to model rules), Ind AS 21 - the effect of changes in foreign exchange rates and on Ind AS 107 - Financial Instruments, applicable w.e.f. April 1, 2025. The company has evaluated the new pronouncements and has concluded that it does not have any impact in its financial statements.

Note 35: Nature and extent of risks arising from financial instruments and respective financial risk management objectives and policies

The Company has adequate internal processes to assess, monitor and manage financial risks. These risks include market risk (including currency risk, interest risk and equity price risk), credit risk and liquidity risk.

The Company seeks to minimise the effect of these risks by using financial instruments such as foreign currency forward contracts and appropriate risk management policies. The Company does not enter into trade financial instruments, including derivative financial instruments for speculative purposes.

1. Market Risk :

a) Foreign currency riskmanagement :

The Company is exposed to foreign exchange risk on account of exports. The Company has a forex policy in place whose objective is to reduce foreign exchange risk by deploying the appropriate hedging strategies (forward covers) and also by maintaining reasonable open exposures within the approved parameters depending on the future outlook on currencies.

The Company's exposure to foreign currency risk is influenced by external macroeconomic factors, including global geopolitical developments, international trade dynamics, and monetary policy actions in major economies, which may result in increased volatility in foreign exchange rates. Further, movements in the Indian Rupee, including potential depreciation against major currencies, may impact the Company's earnings and cash flows.

b) Interest rate riskmanagement :

The Company uses cash credit for working capital and used profits for maintenance and small capex, During the year, the Company is not exposed to significant interest rate risk as it does not have any interest-bearing borrowings or financial assets that are sensitive to interest rate movements. Accordingly, changes in market interest rates are not expected to have any material impact on the Company's financial statements.

c) Equity Price Risk :

The Company's listed equity securities are susceptible to market price risk arising from uncertainties about future values of the investment securities. The Company manages the equity price risk through diversification, by placing limits on equity instruments and partly routing through portfolio management services. Reports on the equity portfolio are submitted to the Company's senior management on a regular basis. The Company's Board of Directors reviews and approves all equity investment decisions.

Increase or decrease in equity prices by 5% would the expose the listed equity securities at fair value of ₹ 83.88 lakhs by ₹ 4.19 lakhs as at 31st March 2026 (₹ 71.44 lakhs - as on 31st March 2025).

The Company is exposed to commodity price risk and supply risk in respect of its key raw materials, which are primarily derived from crude oil. Fluctuations in global crude oil prices have a direct impact on the cost of feedstock such as naphtha, Isobutylene, butane, and other petrochemical intermediates. These price movements are influenced by several factors, including ongoing geopolitical tensions in key energy-producing regions, decisions by major oil-producing countries (including OPEC), global demand-supply dynamics, and currency fluctuations.

In the current environment, heightened geopolitical uncertainties and regional conflicts have led to increased volatility in global energy markets, thereby impacting crude oil prices and supply chains. This, in turn, has a direct bearing on the Company's input costs and procurement strategies.

In addition to price volatility, the Company is exposed to risks relating to the availability of raw materials in the required quantity. Supply disruptions, changes in product specifications, trade restrictions, or logistical constraints may adversely affect operational continuity and cost efficiency.

Further, the Company has experienced supply constraints arising from force majeure-like conditions linked to the recent geopolitical developments in the Middle East region, which have resulted in restrictions in gas supply. The Company has also been informed that the Ministry of Petroleum and Natural Gas, Government of India, has issued directions to refineries to prioritise and divert supplies for domestic LPG requirements and suspend feedstock supplies to downstream industries. This has led to constrained availability of key raw materials for the Company, thereby impacting procurement and operations.

2. Credit risk management :

Credit risk refers to the risk that a counter party will default on its contractual obligations resulting in financial loss to the Company. The Company is exposed to credit risk from its operating activities (primarily trade receivables) and from its investing activities, including deposits with banks and financial institutions.

Customer credit risk is managed by each business unit subject to the Company's established policy, procedures and controls relating to the customer credit risk management. The Company uses financial information and past experience to evaluate credit quality of majority of its customers and individual credit limits are defined in accordance with this assessment. Outstanding receivables and credit worthiness of its counter parties are periodically monitored and taken up on a case to case basis. The Company evaluates the concentration of risk with respect to trade receivables as low, as the major chunk of trade receivables is from oil PSUs and companies with high credit rating. Export markets for spot customers were backed by letter of credit. There is no material expected credit loss based on the past experience. The Company assesses the impairment of trade receivables as per the accounting policy and creates loss allowances, if required.

3. Liquidity risk management :

The Company manages liquidity risk by maintaining adequate reserves, banking facilities and reserve borrowing facilities, by continuously monitoring forecast and actual cash flows, and by matching the maturity profiles of financial assets and liabilities.
